Our mission is to inspire and enable all youth, especially those who need us most, to reach their full potential as productive, caring and responsible citizens.

Our home club is a 41,000 square foot facility at 3535 N. Western Ave. in Memorial Park, that now serves over 400 youth ages 6-18 daily, after school and during school breaks. We also provide opportunities for over 900 additional youth through our other Club sites located throughout Oklahoma County.

Kids in our country are in crisis, a situation which makes the American Dream vulnerable to extinction for many. With growing opportunity gaps in our community and nation that are only being exacerbated by the pandemic, Boys & Girls Clubs are more necessary than ever to create opportunities for youth that give them hope and inspiration to reach their potential and create a better community. Much attention will be needing in the coming years to recover from the academic learning loss and emotional setbacks caused by mandated school closures and isolation during the pandemic.

Our three Priority Outcomes for the over 4,500 Club kids we serve each year are:

- Healthy Lifestyles - making wise choices with nutrition, exercise, positive relationships, life choices, and emotional well-being

Boys & Girls Clubs of Oklahoma County is part of Boys & Girls Clubs of America (BGCA) that provides significant research regarding programs and practices that have the most positive impacts on youth and can often help change the trajectory for a child's future. We are also a United Way partner agency which involved significant oversight and accountability. We charge only a \$10/year membership fee to ensure we are serving youth with the highest need and depend on local community support through individuals, foundations and businesses. Each \$1.00 invested in the Boys & Girls Clubs results in a \$14.62 Return on Investment for the community!

Significant Activity:

In order to respond to the significant challenges our youth are experiencing during the pandemic, particularly when schools were closed and many did not have access to WiFi or food, Boys & Girls Clubs of Oklahoma County opened seven HOPE Centers. These HOPE Centers were open 10 - 12 hours per day, provided meals and snacks, academic support, WiFi, computers, enrichment activities, social and emotional well-being support, and much more. Funding for the extensive costs associated with these HOPE Centers came initially from Oklahoma DHS, and was continued by the generous support of many donors.

Over the past year, we further expanded our reach by opening additional Clubs in areas where youth were disproportionately impacted by COVID. We now run a total of 18 Clubs throughout Oklahoma County. These new Clubs were intentionally opened in areas where youth are struggling academically, socially and emotionally, and where kids may be hungry or lack access to enrichment activities.
